**SUMMARY ANNUAL REPORT FOR
CENTRAL ILLINOIS CARPENTERS HEALTH AND WELFARE TRUST FUND**

This is a summary of the annual report for the Central Illinois Carpenters Health and Welfare Trust Fund, Identification Number 37-1117215, for the fiscal plan year beginning May 1, 2006, and ending April 30, 2007. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974, (ERISA). The Central Illinois Carpenters Health and Welfare Trust Fund has committed itself to pay certain medical, life, dental, vision, and loss of time claims under the terms of the plan.

Insurance Information

The Trust Fund has a contract with Union Labor Life Insurance Company to pay the following types of claims incurred under the terms of the plan:

- Stop-loss claims

Because it is a so-called, experience-rated contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending April 30, 2007, the premiums paid under such experience-rated contract were \$448,925 and the total of all benefit claims paid under the experience-rated contract during the plan year was \$242,321.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$23,751,195 as of April 30, 2007, compared to \$20,747,470 as of May 1, 2006. During the plan year, the plan experienced an increase in its net assets of \$3,003,725. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$28,203,673; including employer contributions of \$25,278,813, employee contributions of \$1,377,830, realized gains of \$20,013 from the sale of assets, and earnings from investments of \$1,298,397.

Plan expenses were \$25,199,948. These expenses included \$1,213,954 in administrative expenses and \$23,985,994 in benefits paid to participants and beneficiaries, and \$0 in other expenses.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs does not include a charge for the copying of these portions of the report, because these portions are furnished without charge.
